



(Incorporated),

For the Year Ending 30th June, 1926.

TO THE GOVERNORS AND SUBSCRIBERS.

Your Board has the honor to lay before you for your consideration the Report and Balance Sheet for the year ended 30th June, 1926.

### FINANCIAL.

The Income for the year was £10,434/12/3, and the Expenditure £10,454/3/4. The year finished with an overdraft of £19/11/1, as against an overdraft of £351/1/3 on 30th June, 1925.

### 1—HOME.

The daily average number of inmates for the year was 197.57. The number of inmates in the Home on 30th June, 1926, is 189.

## OFFICE-BEARERS.

J. Hoare. It will also be necessary to elect Honorary Solicitor, Honorary Medical Officers, Honorary Dentist, Honorary Oculist, and two Auditors.

## GENERAL.

In concluding my second term as your President, I am pleased to be able to state that the affairs of the Home have received generous attention from the public of Ballarat.

## ENTERTAINMENTS.

During the year entertainment was provided for the inmates by the following :—St. Andrew's Choir, Skipton Street Choir, Mrs. Branston's Party, Miss Eunice Lloyd's Team, Mrs. Matthew's

Party, Orphanage Band, Blind Entertainers, Lucas' Girls, Concert arranged by Mrs. Sandall, Concert arranged by Mr. Cedric Gower, Mr. Boustead and Party. The Ladies' High Tea, organised by the Misses Taylor and Mrs. Greenwood and others, was provided as usual, this being the 25th Annual Tea supplied.

## CHRISTMAS TREATS.

The Committee of ladies who organise collections for a Christmas Treat and Christmas Tree, again gave our inmates great pleasure at Christmas time. These ladies also provided several special teas and tobacco, fish and cheese. The inmates greatly appreciate the kindly attentions of this Ladies' Committee.

## SPIRITUAL HELP.

The Clergy, representing all denominations, were attentive to the spiritual requirements of our aged inmates.

## CHARITY SUNDAY COLLECTIONS.

Through the effort of Mr. G. H. Ballhausen, we are again in receipt of a substantial donation of £102/2/8 from the Charity Sunday Committee.

## JUNIOR RED CROSS.

The pupils at Dana Street, State School, formed a Junior Red Cross organisation, under the direction of their Head Master, Mr. N. F. Spielvogel, and donated a portion of the results of their self denial work to our old fold. I have to thank these young enthusiasts for their kindly attention to our inmates.

## MATERNITY WARD.

Owing to the decision of the Charities' Board to establish a Maternity Ward at the Ballarat District Hospital, it became necessary for us to close our Maternity Ward. This branch of our activities had for many years been a valuable and greatly appreciated adjunct to our Institution. The rooms thus made available have been utilised for nurses' quarters, and thereby our female staff has obtained a much needed improvement in accommodation.

## ADDITION TO BUILDINGS.

Plans for building a new Female Infirmary Ward, and also altering the cottages to provide comfortable sheltered seats for the old women have been completed. It is expected that these additions will soon be taken in hand. Many other heavy expenses face us, such as sewerage the building, an additional male sick ward, and also a suitable hall for concerts and entertainments.

## WIRELESS.

Arrangements are now in progress for installing a wireless set. It has been found that the entertainment provided in this way gives our old folk great pleasure. The funds necessary have been supplied by the members of the Board and other Ballarat friends.

## HONORARY STAFF.

It is again necessary to record our thanks to the members of our Honorary Staff for the valuable services rendered throughout the year. In particular, our generous and at all times obliging friend, Mr. F. Pinkerton, must be thanked for his valuable assistance as Honorary Legal Adviser.

## THE STAFF.

The general staff, under the control of our Superintendent and Secretary, Mr. Con. H. Burrow, ably assisted by our Matron, Sister Gent, deserve the appreciation of this Board and our Subscribers. The work of the Staff is all that could be desired, and in every department our Benevolent Home is well served by its loyal and efficient staff. The vegetable garden, which is the pride of Mr. Burrow, continues to supply our patients with an abundance of fresh, wholesome vegetable food.

## THE PRESS.

The Ballarat Press is always helpful in bringing the need of this Institution before the public. My best thanks are due to the proprietors of the daily and other newspapers.

## CONCLUSION.

I cannot close this report without personally expressing on behalf of Mrs. Hoare as well as myself, our deep appreciation of the services of the members of this Board of Management. Whenever we have had occasion to call on them for extra assistance, either by service or financial aid, they have willingly and promptly responded. Our year of office has thus been made easier. Working as we all are for the benefit of the aged and the infirm it is well to reflect that this, my second year of office, has passed with the cordial cooperation of all the members of this Board.




